### REGISTRATION

### RULES

*Right of Admission* : Players who have played in unauthorised tournament listed by All India Chess Federation are not allowed to participate in this tournament.

PCA CHESS ACADEMY reserves the right to admit/refuse any entry without assigning any reason.

*Tournament Rules* : System of Play : The tournament will be conducted as per FIDE law of chess, System of play - FIDE SWISS LEAGUE SYSTEM with 9 rounds. Time control will be 03 Min.

+ 02 Sec. increment per move.

*Tie Break* : In case of tie, the latest FIDE rules shall come in effect. The Cash prize will not be shared.

*Chess Clock* : Players are requested to bring their own chess clocks.

*Protests* : Protest if any against the decision of the Chief Arbiter, shall be made in writing with a protest fee of Rs. 500/- within 15 minutes of occurrence of the incident. The amount shall be refunded if the appeal is upheld.
